#### Jabberwock History

The Jabberwock is a fundraising event dedicated to scholarships and public service programs. It was originally conceived as a unique way to raise funds for scholarships. "Jabberwock," copyrighted by Delta Sigma Theta Sorority, Inc., is inspired by Lewis Carroll's poem "Jabberwocky" from Alice's Adventures in Wonderland. In the poem, creatures from across the kingdom gather annually for a grand pageant.

The inaugural Jabberwock was held in 1925 in Boston, Massachusetts, by members of the Iota Chapter as a new method of raising money for their scholarship fund. Originally envisioned as a musical variety show featuring skits and dances, the Jabberwock has evolved into a more diverse program that continues to raise funds for scholarships.

Historically, Jabberwock funds were designated for scholarships awarded by the sponsoring chapter to promising youth and for public service projects. Today, the event represents an evening of sophistication and entertainment, highlighting the accomplishments of young women while furthering the goals of Delta's scholarship program.

Participants in the Jabberwock are high school seniors. Each participant is encouraged to engage in fundraising activities to compete for the title of Miss Jabberwock and the associated scholarship funds. The Jabberwock Scholarship Presentation is scheduled for tentative, March 29th.

#### 2026 Miss Jabberwock Presentation Eligibility Requirements

In order to be eligible to participate in the March 29, 2026, Jabberwock Presentation sponsored by the Fort Worth Alumnae Chapter of Delta Sigma Theta Sorority, Inc. all participants must meet the following requirements:

- 1. Be a female senior, graduating during the 2025 2026 school year.
- 2. Must be single, never married, and have no children.
- 3. Must exhibit good character.
- 4. Sign along with parent(s) or legal guardian, the Jabberwock Agreement/Liability Release Form.
- 5. Participants **must submit a \$500** fee to participate in the 2026 Miss Jabberwock Presentation. This fee is non-refundable and non-transferrable if the participant withdraws from the competition. The \$500 must be submitted by November 30, 2025 to the designated payment link. To be eligible for the title of Miss Jabberwock, a minimum of \$750 must be raised and submitted.
- 6. Participants are encouraged to sell a minimum of three (3) tickets to the Miss Jabberwock Scholarship Presentation in March 2026. Final ticket sales are March 15, 2026.
- 7. Must obtain one (1) recommendation letter from an academic official (school counselor, teacher, principal).
- 8. Must make every effort to attend all rehearsals and workshops for attendance is highly encouraged. Please communicate with the chairs of Jabberwock if you will be absent from any rehearsal or workshop. A point system will be used to track attendance at workshops and rehearsals to provide additional rewards and recognition at the presentation to qualified participants. *If you cannot attend, please inform the chair of Jabberwock within 48 hrs before the workshop/rehearsal.*
- 10. Participants must wear a formal white ball gown for the Jabberwock Presentation.
- 11. Participants have the option to showcase a talent that will not impact the crowning of Miss Jabberwock.
- 12. Must comply with the Youth Participant Virtual Meeting and Publicity Code of Conduct.
- 13. Must keep all fundraising activities in good taste and be representative of the sorority.
- 14. Must submit all funds solicited to the financial agent of Fort Worth Alumnae Chapter of Delta Sigma Theta Sorority, Incorporated at reporting periods.
- 15. Must not modify the official ad solicitation letter personally signed by the chapter's President, Demetrice Thompson, although a personal note or attachment may be included.
- 16. Parents may use crowdfunding (e.g. GoFundMe) to support their child's efforts but the sites must be reviewed and approved by the chapter president prior to launch. Crowdfunding accounts will be monitored, and a detailed report of all monies collected must be submitted before the last collection date. All monies are due *Friday, March 6, 2026, at 11:59 pm. All monies collected after March 6th will be applied to the scholarship, but will not count towards the crowning for the title of Miss Jabberwock.*
- 17. Participants are highly encouraged to submit essays to the Barbara Jordan Essay Contest, provided they meet the eligibility requirements and deadlines.

## 2026 MISS JABBERWOCK PRESENTATION YOUTH INITIATIVE VIRTUAL MEETING AND PUBLICITY CODE OF CONDUCT

The Youth Participant Virtual Meeting and Publicity Code of Conduct serves as codified guidance for youth participation in Delta's Youth Initiative Programs, namely those of a virtual nature. Your signature on the Participation agreement indicates your complete understanding and agreement to comply with this Code of Conduct.

Failure to comply with this Code of Conduct may result in loss of privileges and/or removal from Delta's Virtual Youth Initiative Programs. As a youth participant in Delta's Virtual Youth Initiative Programs you are expected to:

- Refrain from the use of any profane, foul, hurtful, obscene, or vulgar language in any virtual chatroom and during the virtual meetings and events;
- Refrain from engaging in any violence, cyber-bullying<sup>1</sup>, or other aggressive behaviors that may threaten the welfare of other participants;
- Refrain from any disruptive behavior that may disrupt the virtual meetings and events;
- Be properly groomed and dressed for all virtual youth initiative meetings and events, refrain from wearing articles of clothing that display profane or obscene language and/or images;
- Keep your camera on at all times during all virtual youth initiative meetings and events;
- Provide a noise-free environment while participating in any and all virtual youth initiative meetings and events;
- Refrain from taking, presenting, and posting any photographs, screenshots, video recordings, and/or screen recordings of any virtual youth initiative meetings or any confidential information disseminated during any virtual youth initiative meetings;
- Refrain from taking, presenting, and posting any and all inappropriate content including photographs, screenshots, video recordings, and/or screen recordings of any other youth participants of Delta's youth initiative programs;
- Contact the leader of your youth initiative program if you have any questions or need clarification regarding the Code of Conduct.

#### SANCTIONS FOR VIOLATING CODE OF CONDUCT

- Bad Language/Abusive Teasing and Related Acts:
  - 1st Time: Verbal warning, parent or guardian notified from this point forward
  - 2nd Time: Loss of privileges
  - 3rd Time: 1-week suspension from program
  - Next occurrence youth is removed from the program.
- Physical Violence and Other Misconduct:
  - 1st Time: Removal from situation, loss of privileges, guardian notified from this point forward
  - Next occurrence youth is removed from the program.
- Illegal Substances or Dangerous Weapons <u>1st Time: Youth is removed from the program</u>. If a youth is in possession of an illegal substance or dangerous weapon, the police will be notified as well.
